Read and understand the following waiver statement before signing. ALL participants MUST sign and date this form. If the skater is 17 years of age or younger, the parent/guardian must also print and sign their name and date this form.

For and in consideration of the PARTICIPANT'S registration with NEW JERSEY RINKS, INC., t/a YOUNG'S SKATING CENTER and being allowed to participate in the activity of Roller Skating, the participant and/or participant's parent(s) and/or participant's legal guardian(s) (The undersigned) relinquish any and all liability for and cause of action for personal injury, property damage or wrongful death occurring to PARTICIPANT arising out of participation in the activity of Roller Skating and its associated activities and by this agreement any such claims, rights, and causes of action that PARTICIPANT may have are hereby relinquished and the PARTICIPANT (or parent(s)/legal guardian(s)) does (do) so on behalf of my/our and PARTICIPANT'S heirs, executors, administrator's and assigns.

PARTICIPANT and/or participant's parent(s)/guardian(s) acknowledge, understand and assume all risks inherent to Roller Skating and any member team activities, and understand that said sport and associated activities involve risk to PARTICIPANT'S person including bodily injury, partial or total disability, paralysis and death, and damages which may arise there from and that I/we have full knowledge of said risks. These risks and damages may be caused by the negligence of the PARTICIPANT or the negligence of others, including the "RELEASEES" identified below. It is further acknowledged that there may be risks and dangers not known or are not reasonably foreseeable at this time.

PARTICIPANT and/or participant's parent(s)/guardian(s) acknowledge, understand and assume the risks arising from the conditions and use of the facilities in or on the premises under the auspices of NEW JERSEY RINKS, INC., t/a YOUNG'S SKATING CENTER and acknowledges and understands that included within the scope of this waiver and release is any cause of action, arising from the performance, or failure to perform maintenance, inspection, supervision or control of said premises and for the failure to warn of dangerous conditions existing at said premises, for negligent selection of certain RELEASEES, or negligent supervision or instruction by RELEASEES.

IT IS THE PURPOSE OF THIS AGREEMENT TO EXEMPT, WAIVE AND RELIEVE RELEASEES FROM LIABILITY FOR PERSONAL INJURY, PROPERTY DAMAGE, AND WRONGFUL DEATH CAUSED BY ANY NEGLIGENCE OF RELEASEES.

"RELEASEES" include NEW JERSEY RINKS, INC., t/a YOUNG'S SKATING CENTER, National Associations, Local Associations, Member teams, event hosts, other participants, coaches, officials, sponsors, advertisers, owners, and operators of the premises used to conduct any event and each of them, their officers, directors, agents and employees.

PARTICIPANT or participant's parent(s)/guardian(s) agree if any claim for PARTICIPANT'S personal injury or wrongful death is commenced against RELEASEES, he/she shall defend, indemnify and save harmless RELEASEES from any and all claims or causes of action by whomever or whatever made or presents for PARTICIPANT'S personal injuries, property damage or wrongful death.

PARTICIPANT AND/OR PARTICIPANT'S PARENT(S)/GUARDIAN(S) ACKNOWLEDGE THEY HAVE READ THE ABOVE PARAGRAPHS AND THE PRECEDING TERMS AND CONDITIONS AND HAVE NOT RELIED UPON ANY REPRESENTATIONS OF RELEASEES, THAT THEY ARE FULLY ADVISED OF THE POTENTIAL DANGERS OF ROLLER SKATING AND SIGN THE DOCUMENT VOLUNTARILY, UNDERSTANDING THAT IT IS NECESSARY TO ALLOW AMATEUR ROLLER SKATING TO EXIST IN ITS PRESENT FORM.
